Neshek Laser Tag Agreement:

- 1. I agree to pay 10% of the agree upon price, in order to confirm my reservation. The other 90% is due the day of the event.
- 2. Laser tag will begin promptly at the agreed upon time and address listed above. Please have your play area clean and prepared 30 minutes before the scheduled game time so the Neshek crew can set up the field. If the Neshek crew does start the event late due to heavy traffic, weather, or any other circumstance that may arise the Neshek crew will add any missed time onto the back end of the event to fulfill the entire time that was purchased. Game time starts when our ref starts the debriefing/introduction of rules not when game starts. The rules can take 5-25 minutes depending on how many questions the players have, or how much time is spent interrupting the game coach during directions.
- 3. In the event of rain the game will be played indoors. If no indoor option is available, the party will be pro-rated to the amount of time played. When scheduling permits, the time not played due to weather postponement may be added to the end of the party to fulfill amount of time indicated on the invoice. If no time is played due to poor weather, Neshek will reschedule the date of your party on whatever date host requests within 1 year of date of party (subject to availability) and will apply the deposit you initially paid to the newly scheduled event.

 4. If water breaks, birthday cake breaks, food breaks, etc.... take place during our scheduled time they will be considered "playtime" as well.
- 5. To prevent injuries from happening to any players during game play the referees rules are to be followed at all times. Adequate warning will be provided to players who break rules. Those who disregard rules on a repeated and deliberate basis, or otherwise misbehaves in a disruptive fashion, may be asked to sit out some, or even all remaining games for the duration of the party. Players may also be asked to leave the immediate play area. No refunds or credit will be issued to the party host on the basis of any person's misbehavior, and payment of the remaining balance will still be due.
- 6. Neshek Mobile Laser Tag operates based on scheduled reservations. When a customer has an reservation-scheduled, this is a confirmation that the event will take place both on behalf of the customer as well as the Neshek crew. By having the event scheduled, this eliminates another customer from booking their event during the same time frame, thus blocking out the possibility of Neshek from bringing in revenue for that time slot.
- 7. If an event is canceled at least 7 days prior to the event with a written notice, the host can reschedule the event but the paid 10% deposit will not be refunded. If there is a cancellation within 7 days of the event, the host will have to pay a cancellation fee of 25% of the entire party price. This excludes cancellation due to weather, which would fall under section 2 of this agreement, and extenuating circumstances related to Covid-19.
